I recognize and acknowledge that certain risks of physical injury to participants are possible and I agree to assume the full risk of any such injuries, damages or losses, regardless of severity, which I or my child may sustain as a result of attending GiGi's Playhouse and/or participating in any activities or programs.

While GiGi's is committed to following all recommended precautions to prevent the spread of COVID-19, it cannot guarantee that attendance at GiGi's Playhouse or participation in its on-site programs will not expose participants or volunteers to risk of infection.
