Ohio lawmakers won't take up pension rate hike bill

State lawmakers won't give a pension fund covering Ohio's police and firefighters a rate increase but the retirement system leaders promise they'll ask again next year.

Ohio Police & Fire Pension Fund Director Mary Beth Foley called it a "disappointment" that state senators decided against approving legislation that would have increased how much employers are required to pay into the system.

House Bill 296 would've increased the employer contribution rate from 19.5% for police and 24% for firefighters to 24% for both police and firefighters. Employees currently pay 12.25% toward their police and fire pension. The bill called for increasing the employee contribution rate to 12.5%.

But cities, townships and villages that employ police officers said the rate hike would've cost them \$78 million a year and cut into their ability to hire new officers or give pay raises. Local government groups asked

lawmakers to pump the brakes on the proposal, giving time to come up with alternatives.

While the Ohio House approved the bill, Senate leaders signaled they'd rather not rush the decision.

Any bills that don't clear both chambers in the Ohio General Assembly this week will die and would have to be reintroduced next year.

A similar bill introduced last legislative session to shore up the police and fire pension fund failed to pass.

The fund reduced its assumed annual rate of return – how much it expects to make each year off investments – from 8% to 7.5%. That move caused its unfunded liabilities to increase on paper. State law requires the five public pension systems to be able to pay off their liabilities within 30 years. Without either funding increases or benefit cuts, Ohio Police & Fire Pension Fund will likely be out of compliance with the 30-year requirement in the coming years.
