DAYLIGHT SAVING TIME ENDS



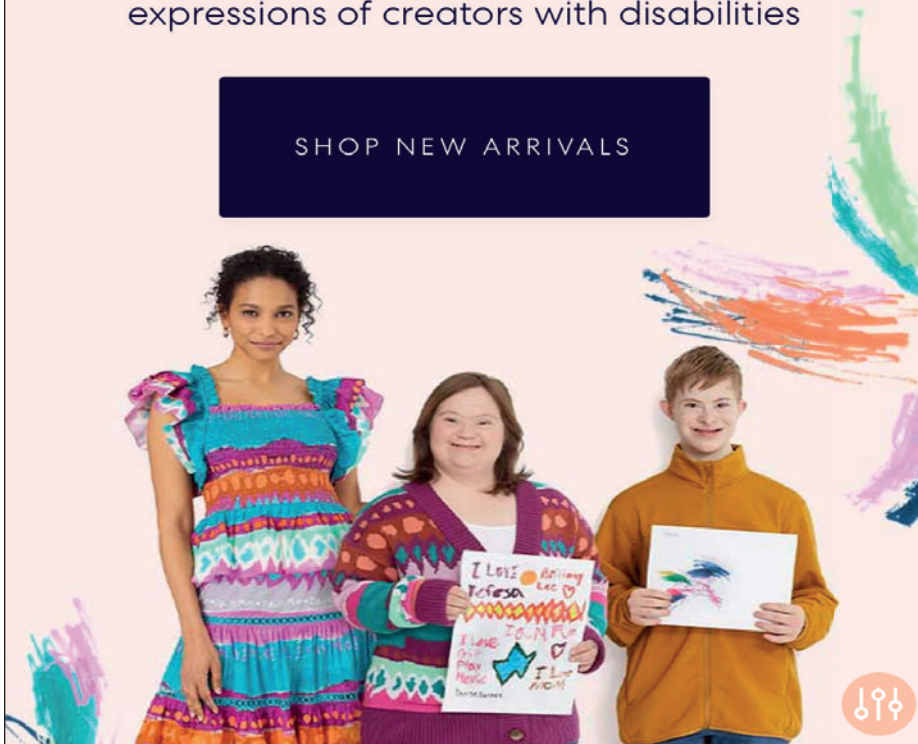

Floyd Bennett Set To Open

By the time you are reading this the first of the expected 2,000+ illegal immigrants are expected to or maybe already have started to move into the massive multi-tent migrant camp at Floyd Bennett Field in Brooklyn. Despite multiple pending lawsuits (including one that will be argued today, November 3rd in Staten Island), fire and safety concerns, and a lack of basic services in the area, close to 500 families are slated to be moved into the camp.

The FDNY have stated that the area lacks proper fire suppression systems in place, specifically being the closest fire hydrant is over 3,000 feet away from the tent city. To compensate for the lack of hydrants, a well placed FDNY Source has said that any response to the area for a fire will include an additional 4 engines and a satellite pumper. In addition, a private ambulance company will be contracted to be on site for medical emergencies because of the long distance the closest FDNY Ambulances would have to travel to respond.

NYC Councilmember for our area Joann Ariola had the following to say "My office will be continuing to fight this battle in the courtroom, and we will also be assisting local residents who want to organize and protest outside of the Floyd Bennett Field entrance. Additionally, we will be conducting regular Zoom meetings as well, so that residents in our area can stay informed with the most up-to-date information about the shelter site as possible. Keep your eyes out on our social media pages to see when those meetings will be posted, and as always, if you ever have any questions please reach out to our office at 718-318-6411. My staff is always on hand to help, and they look forward to speaking with you."

If you read this column with any regularity you know I've written a lot lately about the ridiculous use of the National Park Service land at Floyd Bennett Field being used to house illegal immigrants. In what might actually be a new record for the City of New York, construction on the "temporary" tent city was built soup to nuts in just under two and half weeks. This despite the site being flood prone, lacking adequate fire protection and the fact that multiple lawsuits are currently being fought over the issues of misuse of governmental facilities, ignoring of environmental processes prior to construction and the right to shelter act. But, what is really irking me now besides the immigrants expected to be showing up any day now, is that the City is quite tight lipped about how much this whole debacle is actually costing us the taxpayer. Many of the contracts, which seeing how they are being granted under the guise of "emergency actions", are being kept held tighter than KGB cold war style secret. You know these structures that despite being built quickly will not be cheap. Have heard that yet another no bid contract has also been granted to a private ambulance company to keep a unit stationed there 24/7 for as long as the immigrants are there seeing how the area is out of the way for regular FDNY Ambulance crews. As to the inadequate fire protection have heard that if (actually with the City heating the place with diesel heat generators that need to be refueled daily, it's not a question of if, its more like when) there is a fire emergency there, an additional 4 FDNY engines and a satellite pumper will need to be dispatched because the nearest fire hydrants are 3,000 feet from the tent city. HOW MUCH is that costing? Add to that the feeding, washing, sanitary, security and administration costs and the question begs itself HOW MUCH ARE WE PAYING!!!!

Mayor Adams, wouldn't a huge NO VACANY sign hung on each entrance to New York City, be a much cheaper option....

Osteoporosis (Part 2)

I hope everyone had a safe Halloween.

Last week's article was part 1 of a 2-part series. We discussed what osteoporosis is and who can be affected by it. This week is about how to prevent and possibly reverse osteoporosis.

Vitamin K is also needed for bone health. Too little intake is linked to low bone mass, osteoporosis, and fracture risk. Women who consumed

less than 109 mcg of Vitamin K every day were found more likely to break a hip. Vitamin K is mainly found in dark green leafy vegetables. In many studies it suggests that optimal concentrations of both Vitamin D and Vitamin K are beneficial for bone and cardiovascular health.

Meat, salt, caffeine, tobacco, and physical inactivity of most Americans lead to unnaturally rapid loss of calcium through the kidneys, also

because our dairy industry has had a major and thoroughly unhelpful influence on our health. In the United States, we are one of the largest consumers of dairy products. Ironically, we also have the highest rate of osteoporosis. When we control our calcium losses, we need less calcium in our diet.

Women, unfortunately, are more prone to suffer from osteoporosis than men. When they are diagnosed with it, most doctors will recommend estrogen supplements to slow down the degeneration. It has not been shown that it is effective over the long run, and it is rarely able to stop or reverse the condition. Controlling osteoporosis through lifestyle changes is a much safer way.

If you already have osteoporosis, there is a nonprescriptive transdermal cream that has natural progesterone. It may help build healthy

new bone where it has been lost. There is also nature's contribution of an exact copy of natural progesterone in wild yams, soybeans, and certain other plants.

Osteoporosis in men can be identified and addressed using steroids, alcohol, and a lower-than-normal testosterone level. In many of the cases that were studied, the causes are excessive calcium loss and inadequate Vitamin D. The solution is avoiding animal proteins, excess salt and caffeine, tobacco, and to stay or become physically active.

Some people may have trouble absorbing calcium if they have reduced stomach acid. If this is the case, your healthcare provider may recommend hydrochloric acid supplements. Please do not take any vitamins or supplements without speaking to your healthcare provider first.

Two Hundred & forty-six years ago today, General George Washington became aware of a conspiracy to discredit him with Congress, have him relieved as Commander of the Army and replaced by General Horatio Gates.

A Colonel in the French Army Thomas Conway was one of the main instigators in this plot. Conway was born in Ireland, but moved to France when he was six years old and had joined the Irish Brigade of the French Army in 1749.



During the American Revolution, Silas Deane the American ambassador to France, recruited him to the Patriot cause and after meeting with Washington at Morristown in May 1777, he was appointed a brigadier general and assigned to Major General John Sullivan's division. Conway served admirably under Sullivan at the battles of Brandywine, in September 1777, and Germantown in October of the same year. Although regarded as a skillful disciplinarian of infantry, Conway was refused promotion to major general—largely due to the opposition of George Washington, who believed that there were older officers more deserving of the rank.

After the Continental Army suffered several defeats in the fall of 1777, some members of Congress expressed displeasure with Washington's leadership. Believing Congress lacked confidence in Washington, Conway launched a secret correspondence with General Horatio Gates,



bolstering Gates's ambitions and criticizing Washington. The correspondence came to Washington's attention and the American commander wrote to both Conway and Gates (sending the Gates letter through Congress). With the "plot" exposed, congressional support for replacing Washington immediately evaporated. Embarrassed, Conway offered his resignation in March 1778 by way of apology, and was surprised and humiliated when Congress accepted.

However General John Cadwalader took extreme offense to the French officer's attempts to have Washington removed and challenged him to a duel. On July 4, 1778, he was wounded during the duel and believing himself about to die, he wrote a long letter of apology to Washington. But Conway recovered, returned to France, and rejoined the French army. He served in Flanders and India before returning to France after the start of the French Revolution.

In 1793 he was forced to flee France because of support for the royalist cause and died in exile. 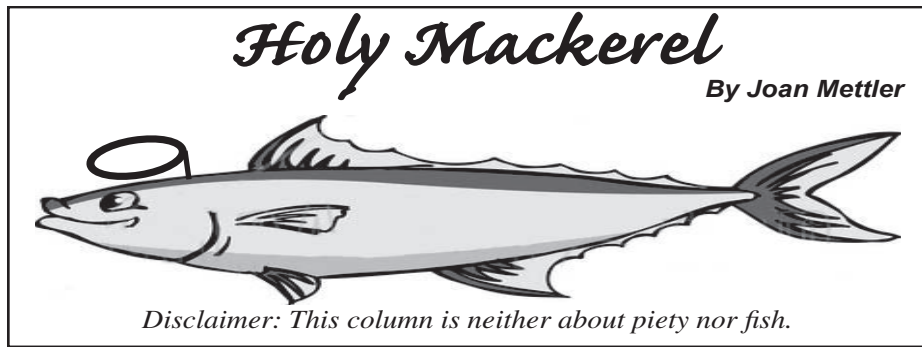

Addressing Mass Murder in America

It must be said that a true public servant serves the public and not himself. In today's world, many civil servants especially those working in congress and on SCOTUS have never had any intention of putting the people's needs before their own. In addition to forgetting their public purpose, many have also forgotten their values, the ones they learned at home from their parents and grandparents; and, in church. Those who have misplaced their morals feel downright at home planted among their peers who have forgotten theirs. And, please don't say these politicians are unaware of the people's preferences when poll after poll indicates trends and the will of the people.

How can politicians continue to ignore the people's needs and still look them straight in the eye? How can the people keep electing them?

Would it surprise you to learn the number one people's preference today is controlling the mass murderer population so that there are no more Marjorie Stonehams, Sandy Hooks and Lewiston Maines? But, doing so is a multi-faceted task. First, we must agree that those who take their assault rifles and mow down Americans are mentally ill. How ill? Just think, if what they did was normal, instead of 566 assault rifle incidents thus far this year, we in America would be confronting several each day. The carnage, the devastation is demoralizing in that our politicians who could pass legislation to control this public menace don't even try. No matter what the personal preferences are for those who assume public office, our politicians and SCOTUS members don't care that they are our proxies. They are consumed with lobbyists 'payments;' in this case the National Rifle Association.

It is no secret that the NRA, not like other associations with bribery use their considerable wealth and clout to influence republican members of congress to steer clear of any firearm legislation. These politicians are the same ones who, after a mass murder by a deranged killer decry, 'now is not the time to discuss gun control.' And, they put the topic so far down the queue of public discussion that by the time they approach it, if they do, public fervor is tempered, exactly what the NRA wants. The new Speaker of the House, when asked to comment on the recent Maine tragedies commented, "It was "not the time" to talk about gun control." "The problem is the human heart." It's not guns, it's not the weapons." "At the end of the day, we have to protect the right of the citizens to protect themselves, and that's the Second Amendment, and that's why our party stands so strongly for that." Yet when a single spree killing happened in New Zealand and Norway it was enough to trigger legislative change. Prime Minister Arden of New Zealand said this, "Every semi-automatic weapon used in the terror attack on Friday will be banned in this country." And so it was spoken and so it was done. Why not here? Is money from the NRA that much of an opiate that it can sway the entire republican membership of congress not to act to even make a tiny effort to prevent future mass murders?

How about the two parties in congress sitting down and designing a plan of action to control the mentally ill assault rifle population? Think what you would do to strategize this horrific problem: First, we must insist on background checks. To make this work, we must include the parents or next of kin as part of the paperwork. They must be willing to

accept responsibility for recommending their offspring as a responsible gun owner. In addition, the application could ask for two endorsements outside the family. But, this is a step for future assault rifle owners. There are already at least 20 million ARs in circulation right now. So, closing the barn door at this point although necessary is not the fix. Government must begin an assault rifle buyback campaign by offering \$5,000 or tax credits for each AR turned in to their local police. Just like passing laws against AK-47's and AR 15's which were in effect from Bush 43's administration through part of Obama's terms, the country was polled wanting restrictions on assault rifles, hundred round clips and bump stocks. AR's this year alone are for sale at a gun show or online or can even be built on a 3D printer.

The family part of focusing police and police psychologists on potentially dangerous mentally impaired gun owners is their eagerness to gain treatment for their son. Encouraging friends of mentally challenged potential mass killers to contact police or dial an emergency telephone number is a crucial part of the plan. AR Clips or magazines must be limited to ten rounds. Not reloading makes the killers' goals easier to achieve. Bump stocks which convert single action rifles into repeating ARs must never be for sale.

Nothing written here is revolutionary. But, all must be taken under consideration immediately, passed and adopted. Whatever the party, if those in congress refuse to represent the needs of Americans with respect to firearm reform, we must vote for those who do. Hold their feet to the fire. We pay them to represent us, not the NRA. When will the insanity stop?

Historical Society Looking for Old Teen Show VHS Tapes and DVDS

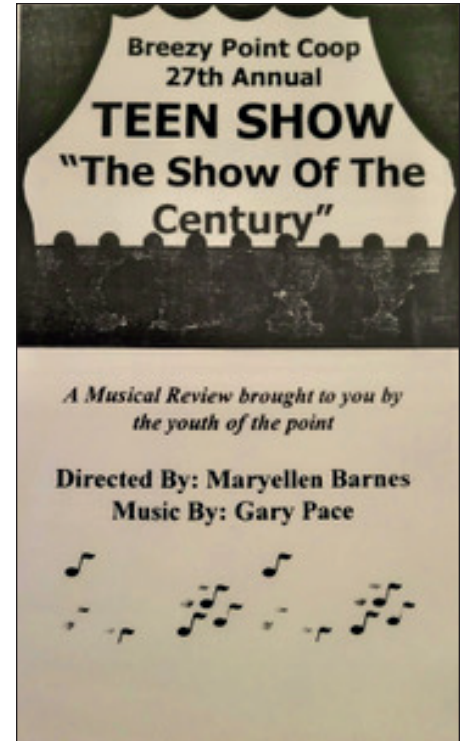

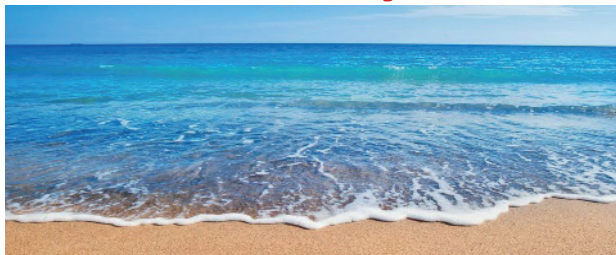

Depending on the answer, you hope to receive you may or may not have come to the right person to answer your question.

SERMON RE-CAP

In 2 Timothy 3:12 Paul says, “Indeed, all who desire to live a godly life in Christ Jesus will be persecuted.” In fact, if you say you are a Christian and never get any pushback from others, you should definitely question your commitment and allegiance to Jesus and your witness to the world. If the world, the flesh, and the devil are not offended by your faithfulness, chances are you are too much like them. That may not sound nice but, the truth is often difficult to hear. Our sovereign, almighty God uses persecution to spread the Gospel. While we in America have been blessed to practice our faith freely and openly, we are often ridiculed by family, friends, or peers when we try to share the Gospel. God’s Word tells us to be humble, meek, gentle, kind, and loving; to “turn the other cheek” and to love our enemies”. In 1 Peter 3:15 we are told, “in your hearts honor Christ the Lord as holy, always being prepared to make a defense to anyone who asks you for a reason for the hope that is in you; yet do it with gentleness and respect” Yet, there are times when we are called to stand firm and fight or contend for the truth. There comes a time when we are to say, “No, not today!” This requires great wisdom to know when and how to act as a follower of Jesus. We need to seek diligently God’s will whenever we act. If the enemy (and here we mean the world, the flesh, and

the devil) is coming for your freedom in Christ, your family, or your peace and joy, we must draw the line and state boldly, “No, not today!” We are, in all situations, to depend upon God’s power and strength to give the victory and to receive the glory. There is a spiritual battle going on, God showed us that very clearly in the Book of Job. Hear these words in Ephesians chapter 6: “Finally, be strong in the Lord and in the strength of his might. Put on the whole armor of God, that you may be able to stand against the schemes of the devil. For we do not wrestle against flesh and blood, but against the rulers, against the authorities, against the cosmic powers over this present darkness, against the spiritual forces of evil in the heavenly places.” Pastor Luigi pleaded with us to remain diligent in prayer, heavily relying on the Holy Spirit, never to surrender to the enemy, until the day we are called home.

Malliotakis Bill to Prevent Migrant Housing on Federal Lands Passes House Committee on Natural Resources

Congresswoman Nicole Malliotakis (NY-11) this week announced her legislation to prevent migrant housing on federal lands was passed out of the House Committee on Natural Resources with bipartisan support and approved for consideration by the entire House with a vote on the floor.

Specifically, the Protecting our Communities from Failure to Secure the Border Act of 2023 (H.R. 5283), would prohibit federal funding from being used to provide housing for illegal immigrants on any land under the jurisdiction of the Federal Land Management agencies, including the National Park Service, the Bureau of Land Management, the U.S. Fish and Wildlife Service and the Forest Service. Both Staten Island’s Fort Wadsworth and Brooklyn’s Floyd Bennett Field are included under this description, along with any other park in the Gateway National Recreation Area.

“Turning our federal parks into encampments for unvetted migrants from all over the world is unfair to surrounding communities and the taxpayers being forced to foot the bill while having their public spaces taken away,” Congresswoman Malliotakis said. “I’ve joined local and

federal colleagues to use every legal and legislative tool at our disposal, from lawsuits to this legislation, to stop the Biden, Hochul and Adams Administrations from taking more open space from our citizens. I appreciate the House Committee on Natural Resources coming to New York City to see the grave misuse of federal land firsthand and thank them for quickly taking up my legislation, putting us one step closer to ending this madness once and for all. It’s my hope that this critically important legislation is brought to the floor as soon as possible.”

House Committee on Natural Resources Chairman Bruce Westerman also worked with the Congresswoman to ensure that, if enacted, the law would retroactively cancel the contract between New York City and the Biden Administration to house migrants at Floyd Bennett Field.

“Biden’s border crisis continues to wreak havoc on America with no end in sight. Instead of working with Congress to secure the border, President Biden has instead chosen to target our national parks to make up for his failures,” said Chairman Bruce Westerman. “H.R. 5283 is vital legislation to stop the absurd precedent of using fed-

eral land to house migrants. Representative Malliotakis has been a strong leader on this issue, and her very district is proof that every state is now a border state under President Biden. With New York City now facing the consequences of Biden's failed policies, it's time for Congress to step in and prevent the administration from turning America's most iconic landscapes into ramshackle camps."

Last month, Malliotakis hosted members of the committee on

a tour of migrant shelters across New York City, including the Roosevelt Hotel in Manhattan and Brooklyn's Floyd Bennett Field. Since then, the Committee has held two hearings on Malliotakis' legislation, which included New York City Council Member Joann Ariola (R-District 32) and New York State Assembly Member Jaime Williams (D-District 59) as witnesses. Both Ariola and Williams are leading a lawsuit with Malliotakis on this same issue.
